THE ANIMAL DISEASES (ANIMALS AND ANIMAL PRODUCTS MOVEMENT CONTROL) (AMENDMENT) REGULATIONS, 2022

Citation and commencement GN. No. 28 of 2007

1. These regulations may be cited as the Animal Diseases (Animal and Animal Products Movement Control) (Amendment) Regulations, 2022 and shall be read as one with the Animal Diseases (Animals and Animal Products Movement Control) Regulations, hereinafter referred to as the "principal Regulations" and shall come into operation on 1<sup>st</sup> July, 2022.

Deletion of regulation 22A

2. The principal Regulations are amended by deleting regulation 22A.

# THE ANIMAL DISEASES (ANIMAL AND ANIMAL PRODUCTS MOVEMENT CONTROL) (AMENDMENT) REGULATIONS, 2020

GN. NO. 28 of 2007 1. These Regulations may be cited as the Animal Diseases (Animal and Animal Products Movement Control) (Amendment) Regulations, 2020 and shall be read as one with the Animal Diseases (Animals and Animal Products Movement Control) Regulations, hereinafter referred to as the "principal Regulations" and shall come into operation on 1st July, 2020.

## Amendment of regulation 6

**2**. The principal Regulations are amended by deleting regulation 6 and substituting for it the following:

"Movement of animals or animal products

- **6.**-(1) A person shall not move migrating or grazing animals or animal products from one area to another within or outside the district without a permit in writing granted and signed by an inspector authorising such movement.
- (2) An inspector shall, prior to granting a movement permit, consult the receiving inspector.
- (3) Permit fees for movement of animals or animal products shall be as set out in the Fourteenth Schedule."

## Amendment of regulation 21

3. The principal Regulations are amended in regulation 21 by deleting the words "which shall be prescribed from time to time by the Director" and substituting for them

the words "as set out in the Fifteenth Schedule".

Addition of regulation 22A

**4**. The principal Regulations are amended by adding immediately after regulation 22 the following:

"Animal and animal products on transit 22A. A person who intends to transit an animal or animal products to another country through Tanzania shall obtain a permit and pay movement permit fees as set out in the Sixteenth Schedule."

Repeal and replacement of Thirteenth, Fourteenth and Fifteenth Schedules **5**. The principal Regulations are amended by deleting the Thirteenth, Fourteenth and Fifteenth Schedules and replacing them with the following:
