THE DAIRY INDUSTRY (TREATMENT AND DISPOSAL OF UNFIT MILK) (AMENDMENT) REGULATIONS, 2020

Citation GN. No. 212 of 2007

1. These Regulations may be cited as the Dairy Industry (Treatment and Disposal of Unfit Milk) (Amendment) Regulation, 2020 and shall be read as one with the Dairy Industry (Treatment and Disposal of Unfit Milk) Regulation, 2007, hereinafter referred to as the "principal Regulations."

Amendment of regulation 3

2. The principal Regulations are amended by deleting the definitions of the terms "Adulteration", "Analysts", "Inspector", "milk" and "voluntary condemnation certificate" and substituting for them the following:

""adulteration" means addition of water or additives or any other substances in milk other than those permitted under the Tanzania Standards;

"analyst" means a qualified officer employed or authorized by the Board for the purpose of analyzing milk samples and reporting the findings to the Registrar;

"voluntary condemnation certificate" means a certificate issued by inspector in respect of seized milk which is unfit for human consumption with the consent of the owner of such milk."

Amendment of regulation 10

3. The principal Regulations are amended in regulation 10, by deleting the words "fifty thousand" and substituting for them the words "one million".

Addition of regulation 10A

4. The principal Regulations are amended by adding immediately after regulation 10 the following:

"Compounding of offence

10A.-(1) Where a person admits in writing that he has committed an offence under these regulations, the Registrar or any authorized officer, in writing, may, at any time prior to the commencement of the proceedings court of competent jurisdiction, compound such offence and order such person to pay a sum of money not exceeding one half of the amount of the fine to which such person would otherwise been liable to pay if he have been convicted of such offence.

- (2) Subject to subregulation (1), a person whose an offence has been compounded shall fill compounding form prescribed in the Sixth Schedule to these Regulations and make payment of penalty imposed within fourteen days.
- (3) Failure to make payment within the prescribed time, a person whose an offence has been compounded shall pay penalty and interest of twenty percent of such penalty."

Amendment of Schedules

- **5.** The principal Regulations are amended in the Schedules by-
 - (a) deleting the Fourth and the Fifth Schedules and replacing for them the following:
