- 1. The Government of the United Republic of Tanzania has received loans/ financing from the World Bank toward the cost of the proposed rehabilitation works and construction of ferry fish market Phase I in Dar-es-salaam and intends to apply part of the proceeds toward payments under the contract.
- 2. The Permanent Secretary (Fisheries), Ministry of Livestock and Fisheries who is the implementing agency now invites sealed bids from eligible bidders for;
 - i. Rehabilitation of existing concrete block work structure, The works involves repair of floors, walls, ceiling, drainage system in zone 1 and zone 2 which include Administration and Auction Block of about 1326 gross floor area and Fish Preparation Zone of about 517 gross floor area complete with associated building services. Demolition, repair and replacement of existing working surfaces made up of timber, concrete, tiles with stainless steel food grade tables, introduction of centralized gas and pest control measures.
 - ii. Rehabilitation and extension of Public Toilets in zone 1 (Administration and Auction Block) from about 75 m² gross floor area to about 96 m² gross floor area, the works involves repair of walls, floors, ceiling, window, doors and replacement of old sanitary fittings with new sanitary fittings, with other associated services.
 - iii. Construction of concrete block work Male and Female Changing rooms in Zone 1 (Administration and Auction Block) of about 52 m² gross floor area. The works involves excavations, earthworks, walling, roofing, finishing, decorations, window, doors and associated services.
 - iv. Rehabilitation of Mechanical and Plumbing System which includes changing of septic tank system to sewage pumping system connected to public sewer, introduction of fish processing water treatment plants (Sequential Batch Reactor)

SBR to ocean, Upgrading and rehabilitation of existing sea waterline to service fish processing area.

- v. Rehabilitation of external works; the works involves repair of boundary walls, concrete pavement, storm water drainage, replacement of entrance gates and associated services.
